

Boiler License Exam Prep

Moore Tech is offering a Boiler License Exam Prep non-credit course for those interested in taking the 1st Class or 3rd Class Steam Operating Engineer License Exam. Having a licensed boiler operator is critical for facilities that have high pressure boilers. **This class will be held online through Zoom.**

In conjunction with the class, Moore Tech also offers the exam for the 1st or 3rd Class Steam License. Once a student passes the exam, the student applies for their actual license through the Shelby County Code Enforcement. The number of years of documented experience, certifications, training, etc. will determine whether you qualify for the 1st Class or the 3rd Class Steam License. The code office located on Mullins Station Rd. may also consider the training you receive in this boiler license prep course. The boiler license exam will be a 3 hour open-book exam based on the High Pressure Boiler 6th edition by Steingress. The book is included with the course.

Classes are scheduled so that if your work schedule changes, students can alternate back and forth between the 8:30 a.m. to 6:30 p.m. class times.

The exam is scheduled the following week after the exam prep class has ended. The exam fee is waived for students enrolled in the Moore Tech exam prep class.

Approximately 1-2 weeks following the exam, Moore Tech will notify the student and Shelby County Code Enforcement by email whether or not they passed and their score. A score of 70 is passing. Students who pass can then submit their exam notice and complete their application for their license at Shelby County Code Enforcement.

Students should register early to reserve their space. A full refund of course fees will be granted if requested at least (2) full business days prior to the class start date. No refunds will be made after the class begins.
